



New Hope Canoe Club Waiver

Plain Language Release from Legal Liability for Injuries

I, _____, "Releaser", in consideration of being permitted to participate in the sport of canoe paddling with the New Hope Canoe Club, "Club", release and hold harmless the Club, New Hope Christian Fellowship O`ahu, New Hope O`ahu and O`ahu South Foursquare church from any and every claim, demand, action, or right of action of whatever kind or nature arising from damage and/or personal injury resulting from any accident which may arise from the Releaser's participation in canoe paddling or any activities in connection with canoe paddling (including social activities), caused by the negligence or any other act or conduct of the coaches and members of the Club, or any employee, officer, or director of New Hope Christian Fellowship O`ahu, New Hope O`ahu and O`ahu South Foursquare Church. I release, waive, discharge and covenant not to sue New Hope Canoe Club, New Hope Christian Fellowship O`ahu, New Hope O`ahu and O`ahu South Foursquare Church, its member associations, its affiliated clubs, their respective administrators, directors, agents, coaches and other volunteers or employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leasers of premises used to conduct the event, all of which are hereinafter referred to as "releasees", from demands, losses, or damages on account of injury, disability, including death or damage to property, caused or alleged to be caused in whole or part by the negligence of the releasee or otherwise.

I further release all members and coaches from any claim whatsoever I may have on account of first aid, treatment or services rendered or not rendered to me during my participation in this sport. I agree to submit a doctor's note clearing me to participate, if I have a medical condition which may threaten my life or the other participants. **I understand that my participation in this sport may be denied, if the coaching staff determines that by doing so, it may be hazardous to my health or to the other participants, or if my physical conditioning is not at the level it should be at to participate in practices, races or events with the club. I understand that being a member of the New Hope Canoe Club does not guarantee my participation in practices, races or events, but it is determined by the coach's evaluation of my ability to do so.**

This release contains the entire agreement between the Club, New Hope Christian Fellowship O`ahu, New Hope O`ahu, Oahu South Foursquare Church, New Hope International and me, and the terms of this release are a contract.

I have read this release, I understand it, and I sign it as my own free act. I understand that before I sign, I may have my attorney review this release and he or she can explain in detail the full extent of the legal rights I am giving up.
